The Marie Louise Hartzer Bursary has been established to provide financially supported education to students on the basis of financial need.

Marie Louise Hartzer was the first Congregational Leader of the Daughters of Our Lady of the Sacred Heart, known here in Australia as the OLSH Sisters. The OLSH Sisters founded our College in 1938. It was the inspirational and courageous leadership of Marie Louise Hartzer that sent the first five sisters from France to Australia (and beyond) in 1884.

Marie Louise Hartzer was a woman of trusting faith, courage and compassion. Her leadership was characterized by wisdom, kindness, gratitude, hospitality and love. She was deeply dedicated to the education of young women and this tradition has been carried on here in Bentleigh through the lives of the OLSH Sisters and all who have followed or worked with them and through those who carry on this special and precious work today.

We honour the memory of Marie Louise as we invite eligible families to apply for the Marie Louise Hartzer Bursary. This Bursary is for students entering **Year 7 at OLSH College Bentleigh in 2025.**
